## Pro Se, (prō-say) – appearing for oneself instead of retaining a lawyer

Divorce can be a very complicated process. You have full responsibility for complying with all procedural and substantive requirements of the law If all documents are not completed signed notarized and filed as required by law the divorce pleadings are not in compliance with the law a judge cannot grant your request for divorce and may dismiss your case. You are responsible for scheduling with the Court any hearings related to your divorce proceeding. The Court cannot act as your attorney nor can the Court help you prove or defend your case. This action involves important legal rights and the Rome Judicial Circuit urges you to hire an attorney An attorney will be familiar not only with the law but will also be familiar with the procedures of this Court Due to the changing nature of the law and the factual differences in each person s situation these forms may or may not be appropriate in your particular case.
