A History of the Floyd County Program

In 1991 the Floyd

Superior Court began offering the seminar to address the dynamics of the effects of divorce on children and to assist parents in helping their children cope with the divorce. Since then, more than 8,000 parents have attended our sessions, and despite the program's mandatory attendance policy, over 90% of parents attending have rated the program as helpful. As a result, many divorces have become less traumatic, with parents electing to use negotiation over confrontation.

TRANSPARENTINGSM

- IS a four (4) hour class designed to help parents become more aware of the effects of the divorce process on children.
- IS mandatory for all parties where minor children are involved in cases of divorce, separate maintenance, legitimation, and by specific order of the court. Exceptions may be granted where similar counseling or therapy is provided by a third party.
- IS NOT a counseling, therapy or grievance session. Referral information on local resources will be available for those having those needs.
- IS utilized in almost every county in Georgia and 38 other states.
- IS conducted by local practicing therapists and counselors who have received specialized training involving children and the process of divorce.
- IS offered twice per month as either an evening or morning class to attend.

- Child Care is not provided




The seminar emphasizes each parent's responsibility to provide a *nurturing*, non-threatening environment for the child. *Topics include*:

- ♦ Feelings associated with divorce
- ♦ Ways that children of different ages react during transition
- ♦ A parenting approach that will benefit your children
- ♦ Suggested ways for talking to children about divorce
- Other adjustments children will need to make

The course is taught by licensed professionals who have experience with children and who have been specially trained to teach this course. This is an educational program and not a counseling session. Parents will not be expected to discuss personal problems.


